The Agency is rapidly becoming one of the country's largest homebuilders, and is currently advancing 20 sites, including a number of which are under construction and will deliver homes in 2024

Delivery Mechanisms

- **Direct Delivery**: Partnerships with Local Authorities on Public Lands;
- **Project Tosaigh**: Kick-starting stalled or unviable housing projects;
- **Private Land Acquisition**: actively seeking expressions of interest from landowners for sites in the five main cities, with capacity for at least 200 homes.





Direct Delivery

Shanganagh, Shankill, Co Dublin:

- 597 homes brought through planning and procurement;
- LDA commenced partnership with DLR CoCo in 2019;
- Construction commenced Sept 2022
- Phased delivery from Q3, 2024;





Best Practice



- **Sustainability:** Shanganagh largest passive development in Europe;
- **Cambridge model:** Hollystown higher density, community orientated neighbourhood;
- **Building thriving communities:** All developments close to transport links with provision for childcare, retail and community spaces;
- **Collaboration:** Local Authorities, AHBs, private sector.



Project Tosaigh

Market based initiatives

Project Tosaigh Programme

- Accelerating the delivery of affordable homes through a market-based acquisition process
- 5,000 homes delivery target over a four-year period.
- Two routes to markets: (i) forward purchase; and (ii) forward funding

Project Tosaigh I

Forward Purchase

- Expressions of interest process commenced in late 2021
- A focus on higher density schemes in Dublin and Cork
- First phases of acquired units now available for rent / sale with strong pipeline under development

Project Tosaigh II

Forward Funding

- Subject to a public procurement process
- Procurement process launched in July 2023 with a view to establishing a panel / framework by year end
- Will provide the ability to make stage payments during the construction phase
- First call-offs anticipated early 2024





Private Land Acquisition

- Large sites with good planning permission;
- Suitable locations close to existing transport links;
- Clongriffin lands purchased at the end of 2023, with capacity for 2,300 homes;
- Tender for Contractor for Phase One underway;
- Construction due to start Q4 2024.





Services to Local Authorities: Part 15 LDA Act

PART 15 LDA ACT: A local authority may request the Agency to provide services to it in relation to the development of sites for housing and urban development that are:

(a) large scale, multi tenure or mixed-use development sites that may include sites fully or partially intended to secure all or part of an accommodation programme.

(b) located in the area of a town (**equal to or greater than 30,000 persons)**, and on land owned by the local authority to assist the local authority in the performance of its functions.





Services to Local Authorities: Part 15 LDA Act

LDA Organisational Structure

- Preparation of masterplans and carrying out appraisal of development potential of sites;
- Application for development consents, permissions and other approvals in relation to sites;
- Provision of infrastructure to service sites for housing;
- Provision of housing and carrying out of ancillary works as part of wider urban development;
- Management of cost rental housing.
